

## INFORMATION FOR AUTHORS

**Submission of manuscripts:** Manuscripts for publication and correspondence relating to them should be sent to Dr. Binod Acharya, *BDS, MDS, FICD (USA), FPFA (USA)* Editor-in-Chief, Journal of the Nepal Dental Association, Department of Dental Surgery, Kathmandu Model Hospital, GPO Box 6064, Bagbazar, Kathmandu, Nepal; telephone: 00977-1-4248058; e-mail : drbins@hotmail.com or prosthodontist3@yahoo.com

The journal of the Nepal Dental Association publishes articles on original research, clinical observations, or investigations on recent advances; review articles on dentistry and related subject; news, and service announcements.

Manuscripts are accepted for publication with the stipulation that they are original, written in English, and have not been published or submitted for publication elsewhere. Manuscripts will be reviewed by the editor and consultants and are subject to editorial revision. Authors are encouraged to follow the guidelines set out below to expedite the smooth handling of their manuscripts.

Statements and opinions expressed in the articles and communications herein are those of the author(s) and not necessarily those of the editor(s) or publisher, and the editor(s) and publisher disclaim any responsibility or liability for such material. Neither the editor(s) nor the publisher guarantees, warrants, or endorses any product or service advertised in this publication; neither do they guarantee any claim made by the manufacturer of such product or service. Each reader must determine whether to act on the information contained in the publication, and neither the Journal nor its sponsoring organizations shall be liable for any injury due to the publication of erroneous information.

**Authorship:** There should be no more than three authors named on manuscripts in the normal course of events. If there are more than three, the Journal requires that the additional author(s) significantly contributed to the work. If this requirement cannot be met, the additional author(s) may be named in a manuscript footnote.

A cover letter signed by all the authors should identify the person (with the address, telephone and fax numbers, and e-mail address) responsible for negotiations concerning the manuscript. The letter should clearly state that the final manuscript has been seen and approved by all the authors and that they have taken due care to ensure the integrity of the work. "The undersigned author(s) warrants that the article is original, does not infringe upon any copyright or other proprietary right of any third party, is not under consideration by another journal, has not been previously published, and includes any product that may derive from the published journal, whether print or electronic media. I (we) sign for and accept responsibility for releasing this material. "Please be sure to include the title of your article in this statement.

**Format:** Submit the original and two copies (high-quality photocopies accepted), typewritten with double spacing on a side of 'A4' white paper, each page containing no more than 350 words. Do not use heavy binders to package the manuscript and do not mount illustrations on heavy cardboard. The body of the text, not including the abstract, references, table, or illustrations, should not exceed 12 pages in length. A fee will be charge for manuscripts exceeding the 12-page limit. Two consultants may then receive a copy without delay. Remove all evidence of authorship from the two review copies and figures, eg, author name appearing at the top of each page or on the back of each illustration, to expedite the review process. The author should retain another copy for personal reference. (See paragraph on illustrations for submission of these).

### Manuscript organization

The following organization is recommended:

**TITLE PAGE:** The title page should include the title of the article, full name(s) of the author(s), accademic degrees, and institutions affiliations and position; in the interest of anonymity, the information pertaining to the author should appear only on the original manuscript. The corresponding author's address, business and home telephone numbers, fax numbers, and e-mail address should be given.

**ABSTRACT** Provide an abstract of 225 words or less. Briefly state the problem or purpose, the major observations, the methods, and the principal conclusions.

**INTRODUCTION** The purpose of the introduction is to briefly answer the question "Why did you start ?" or "What initiated the research ?" State the study's objective and omit extensive review of the literature, which is normally found in a thesis.

**MATERIALS OR SUBJECTS AND METHODS/CASE HISTORIES:** This section should answer the question "What did you do?" Describe the experimental design procedures and subjects used. Give the details only if the methods are original or essential for understanding; otherwise, give references. Never mix discussion with this section or with the results section.

**RESULTS:** Present the results with a minimum of discussion and answer the question "What answer did you get?" Use tables, charts, and photographs to clarify the findings. Finally, check the statistics, and quote statistical jargon only if you are personally familiar with it.

**DISCUSSION:** Point out the significance of the data and the limitations. Speculation should be clearly identified as such. Do not repeat the introduction in this section. Keep this section to approximately one third of the total manuscript. It should not exceed one half of the complete article's length. Short paragraphs should answer the questions "What did you find out?" and "What does it mean?" This most important second question is answered by discussing your findings in the light of other reports, including opposing views, and is important in limiting bias. Use the last paragraph to suggest extensions of your study.

All measurement should be expressed in metric units, or metric equivalents may appear in parentheses after the original measurement. To avoid confusion caused by varying tooth-numbering system, provide the full name of the tooth and its upper or lower quadrant position.

**CONCLUSION(S) :** Be sure to include a clearly labeled conclusion.

**REFERENCES:** Cite references selectively. Personal communications and unpublished data are not to be cited as references. Instead, indicate these sources in the text at the appropriate place, and append to the manuscript a note of approval from the source for the statement. References to articles in press must include authors' names, title of article, and name of journal. Make sure that all references have been verified, that all have been mentioned in the text, and that numbering of the references matches the order of their mention in the text, ie, reference numbers should appear in consecutive numerical order in the text. The reference list should be typed double-spaced on a separate page. Journal names must be abbreviated according to the Cumulated Index Medicus.

**EXAMPLES** (if six or fewer authors, list all; if seven or more, list first six and add et al.):

- (a) Format for journal articles: Smith BGN, Knight JKK: An index for measuring the wear of teeth. *Br. Dent. J.* 156: 425, 1984
- (b) Format for books: Ash MM, Ramfjord S: Occlusion. W.B. Saunders Company, Philadelphia, 4<sup>th</sup> edn: 125-127-1995
- (c) Format for chapter: Kuroi J, Erikson S, Andresen JO. The impacted maxillary canine. In: Andreasen JO, Petersen JK, Laskin DM, editors. Textbook and color atlas of tooth impactions. Copenhagen: Munksgaard; 126-165, 1997.

**ADDRESS FOR REPRINT REQUEST:** After the reference list in the original manuscript only, type the name and complete mailing address of the author to whom reprint request should be sent.

#### **LEGENDS AND ILLUSTRATIONS:**

All figures must be mentioned sequentially in the text. Each figure must be accompanied by legend. Type all of these together double-spaced on one separate sheet of paper. Each legend should be as short as possible and should identify the figure without repeating information from the text or providing explanations that belong in the text. If a figure has been previously published, the legend must give full credit to the original source. Do not mount figures on heavy cardboard.

**TABLES:** Tables should be self-explanatory and should supplement, not duplicate, the text. Number them in roman numerals according to their order of mention in the text. Provide a brief title for each. Type each table double-spaced on a separate sheet of paper. If a table or any data therein have been previously published, a footnote to the table must give full credit to the original source.

**PERMISSIONS AND PATIENT CONSENT FORMS:** Direct quotations, tables, or illustrations that have appeared in copyrighted material must be accompanied by written permission for their use from the copyright owner and original author, along with complete information regarding the source. Permission also must be obtained for modified table and figures. Photographs of identifiable persons, ie, the eyes and shown, must be accompanied by signed releases from patients or from both living parents or guardian of minors.

**Illustrations:** Three sets of high-contrast glossy prints of illustrations should be included with the manuscript to facilitate the consultants' review. The illustrations must be of good quality. Special arrangements must be made with the editor for inclusion of four-color illustrations. Because of the high cost of four-color reproduction, authors desiring color reproduction will be required to

pay part or all of the cost. If authors wish to have illustrations returned, they should include a written request. A reasonable number of black-and-white illustrations will be reproduced free of cost to the author. Authors with color illustrations can request that they be converted to black and white at no charge. Special arrangements must be made with the editor for elaborate tables or extra illustrations. Illustrations are scanned electronically. For best reproduction, screening, shading, and lettering on a dark background should be avoided. Use patterns to indicate differences in columns. Original artwork, x-ray films, or graph tracings will not be accepted. For line art (charts, graphs, and line drawings), three sets of either laser printouts or glossy prints must be submitted. Illustrations should be numbered in order of their mention in the text and labeled on the back with the figure number, first author's name, and an arrow indicating the top edge. All lettering must be done professionally and should be in proportion to the drawing, graph, or photograph. Glossy print photographs, 3-4 inches (minimum) to 5-7 inches (maximum), with good black-and-white contrast or color balance and preferred. Reproduction can be no better than the quality of the original; reproduction does not correct the exposure or sharpen the focus or contrast of the original print. Consistency in size of illustrations within the articles is strongly preferred. Please indicate the location of the illustrations within the text. Any special instruction regarding sizing should be clearly noted.

**Clinical articles:** Length should be 6 to 10 double-spaced, typewritten pages, each page containing no more than 350 words. Research articles should not exceed 12 pages plus illustrations. Only abbreviated tables and statistics considered absolutely necessary should be included. A footnote may be appended stating that pertinent original research data are available directly from the author.

**Case reports:** Case reports will be evaluated for completeness and quality of records, quality of treatment, uniqueness of the case, and quality of the manuscript. A high-quality manuscript will include the following sections: introduction; diagnosis; etiology; treatment objectives, alternatives, progress, and results; and discussion.

**Must be signed by ALL authors:** "The undersigned author(s) transfers all copyright ownership of the manuscript [title of article] to the Journal of the Nepal Dental Association in the event the work is published.
